**Dario Dongo** is a lawyer, journalist, and adjunct professor of international, European, and national food law—a field he has championed for over thirty years. ### Academic Background

After graduating in Law from the **University of Genoa (1993)**, he earned a Master's degree in European Economic Community Law and Institutions from the same institution. His academic journey continued with an **MBA from EDHEC Business School (2006)**, a second-level Master's in **Corporate Governance and Strategy** from the University of Pisa (2007), and a **PhD in Agri-Food Systems** from the Università Cattolica del Sacro Cuore (2016).

### Legal & Corporate Career

His early legal career, with a specific focus on food safety, labelling, advertising, environmental protection, and occupational health, established the groundwork for his deep understanding of the legal dynamics governing the food supply chain.

As **Head of Legal Affairs for the ERIDANIA-BEGHIN SAY CORPORATION** (formerly the Ferruzzi Group), he supervised all Italian subsidiaries. His remit included international and domestic contracting, legal consultancy, litigation management, and the design of prevention and crisis management protocols for food safety.

For the following decade, as **Director of EU and Regulatory Policies at FEDERALIMENTARE (CONFININDUSTRIA)**, he represented the interests of the Italian and European food industries within key institutional frameworks, including Brussels, Strasbourg, Rome, the **Codex Alimentarius**, ISO TC/34 SC/17, and the **Global Food Safety Initiative (GFSI)**. During this time, he was directly involved in the formation of European Food Law, navigating both the "ascending phase" (drafting and political review) and the "descending phase" (national implementation, interpretation, and the creation of industry guidelines).

### Entrepreneurship and Global Leadership

In 2012, drawing on his extensive industry and institutional expertise, he founded **WIISE benefit SRL**. This includes **FARE**, a division specialized in strategic, technical-legal, regulatory, and public affairs consultancy. FARE supports entities in harmonizing innovation and product excellence with sustainable development, fair trade practices, and strict regulatory compliance (EU and non-EU).

In 2024, he co-founded the **Global Honey Organization (GHO)** in Switzerland, where he currently serves as Secretary General.

## Academia, Journalism, and Publications

A prolific speaker, Dario Dongo has presented at over **300 international seminars** and conferences and has participated in numerous EU-funded research programs. He serves as an **adjunct professor** at the Universities of Turin, Naples Federico II, and Perugia.

As an accredited member of the **Order of Journalists (Lazio)**, he is a prominent voice in public discourse, frequently appearing on television programs such as RAI 3's '*Mi manda Rai Tre*'. His vast bibliography includes books, e-books, and thousands of articles covering food safety, labelling, GMOs, and food law. He co-founded the portal '*Il Fatto Alimentare*' and has contributed to leading publications such as *Il Sole 24 Ore*. He now focuses his editorial efforts on the online platforms **GIFT (Great Italian Food Trade)** and **FOODTIMES**, which promote Italian food excellence and independent reporting on the circular economy, nutrition, and environmental health.
